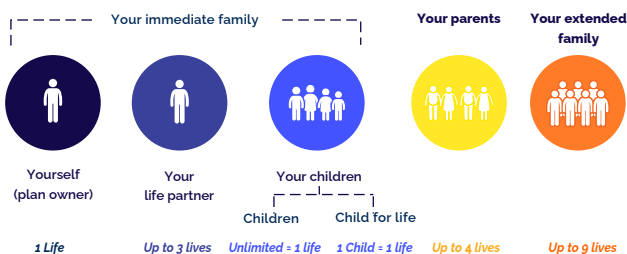

Notes:

- You can choose to cover your parents and extended family without covering yourself. You must still pay the premium even though you are not covered.
- You can add benefits to your Funeral Plans at an extra cost. The add-on benefits can be chosen per insured life.
- The premium for your plan depends on who you'd like to cover, how much cover you take, how old they are and add-on benefits chosen. (They must be younger than 85 years.)

Some unique features and benefits

Customise your plan

You choose the type of cover and benefits for each life individually, to best suit your needs and your budget – even as your life changes.

No medical health checks

We cover you as you are. Only waiting periods apply.

Built-in benefits

▪ Funeral benefit

An amount is paid to cover funeral expenses when someone covered by the plan passes away.

▪ Payment Protection when you, the plan owner, reach age 85

We will cover the cost of your premiums once you, the plan owner, turn 85. All family members covered on this plan will continue to enjoy cover.

▪ Repatriation

Transportation of the deceased person's body is expensive, and this benefit can save you money. It gives all insured lives on this plan access to the following services 24 hours a day, seven days a week, all year long:

- Help to move the deceased's body to the place of burial within South Africa.
- Help with funeral and cremation arrangements.

Add-on benefits

▪ Accidental Death benefit

Double your cover in the event of accidental death. The Accidental Death benefit matches your Funeral cover rand-for-rand, ensuring twice the payout when the unexpected happens.

▪ Memorial

Pays a lump sum amount of up to R20 000 to honour the memory of your loved ones in a fitting way, for example erecting a tombstone. You can choose to receive the money within 18 months after you made the claim.

Add-on benefits

- **Monthly Essentials**

Pays a monthly payout of up to R3 000 for six or 12 months. You can use this to help pay your family's living expenses after the death of an adult family member who used to contribute to your family's income.

- **Payment Protection on plan owner's death or disability or retirement**

Add the Payment Protection on death and disability and/or retirement benefits and we will cover the cost of your premiums when you become disabled, retire or pass away.

- **CashBack**

Add the CashBack benefit and get some of your money back by staying on track with your plan. We will give you 12.5% of your premiums after the first 24 months, and then every 36 months thereafter. Ts & Cs apply.

- **Value Protection**

You can choose to automatically increase your premium and cover by 6% or 10% every year so that your payout keeps up with rising funeral costs.

Features

- **Help in tough times**

We allow up to six premium skips to ensure your plan remains active. You must pay the first premium before you can skip premiums.

- **Reinstate plans quickly**

If your plan lapsed within the past three months, it could continue as usual if you meet certain criteria.

- **Plan continuation**

A family member can take over the plan after you, the plan owner, passed away to ensure your family's funeral cover remains intact.
